1-ADMISSION CONDITIONS : A/ To be allowed to enter, to settle down and to stay in the campsite, even for a visit, one must first obtain permission from the reception (or the management) and one must comply with the campsite regulations. Every violation is subject to the possible expulsion of its offenders. In the case of major violations management reserves the right to contact the local authorities. Staying at the campsite implies acceptance of and compliance with the campsite regulations. Everyone staying at the campsite for at least one night must show upon arrival valid identifications to the reception and fill in the necessary forms required by law. People under the age of 18 wanting to stay on site have to be accompanied by an adult, have to have a parental permission, and have their contract signed by either a parent or the person in charge of them. Campsite's bracelets must be worn - Water park: loose swimming trunks forbidden. B/ The tent or the caravan and its relating equipment have to be set up at the indicated site and in accordance with the instructions provided by the management. Connection of electric power supply must be requested upon arrival at the reception. Only one camping unit (tent, caravan or campervan) per emplacement is allowed. Upon arrival the user must report the length of his stay to the reception and deposit a document certifying civil liability coverage for damages, especially fire, that he might cause to others. C/ Deposits:- For the hire of mobil-homes, bungalows or chalets a deposit of 200€ + 95€ will be required at your arrival for eventual damages and will be given back after the final check-out. D/ It is prohibited for users of the campsite to use it for commercial purposes or commercial advertising. E/ Swimming Pool: It's forbidden the use of cloth and accessories likely to interfere with the swimmer's breathing and to harm in terms of security and hygiene. F.C N°2010-1192 of October 11th, 2010 & the circular of March 2nd, 2011.

2- RECEPTION : Vieux Port : Low season : from 8.30 am to 12.30 am and from 2 pm to 7 pm / high season : from 8.30 am to 8.30 pm without interruption - Pignada : Low season : from 9 am to 12 am and from 2.30 pm to 6.30 pm / high season:- from 8.30 am to 8.30 pm without interruption - Marina : Low season : from 9.30 am to 12 am and from 4 pm to 6.30 pm / high season : from 9 am to 12.30 am and from 2.30 pm to 7.30 pm. At the reception, you can find information about the site, about shops, about sports installations and tourists riches.

3- FEES : A/ Fees are due the day before departure, except for reservations which must be paid before the 1st June, or when you sign the contract, for all hirings after this date. B/ Rates in our booklet are provided for information only. They have been established on the basis of economic indices effective at the time of their printing and may be scaled up or down depending on the changes of those indices (VAT and tourist tax for example).

4- BEHAVIOUR AND APPEARANCE OF INSTALLATIONS : A proper behaviour is required at all times. Refrain from all actions that are harmful to the neatness, hygiene and appearance of the campsite. The users are to avoid all noises and discussions that might bother their neighbours. Audio devices should be set up accordingly. Doors and boots of cars must be closed as silently as possible. There is to be complete silence between 11 pm and 7 am. It's forbidden to throw polluted and used water on the ground. They have to be emptied in the specifically designated installations. Household refuse, waste of all kinds and papers must be thrown into the dustbins. Sanitary installations must be maintained in a constant state of cleanliness. Washing is strictly prohibited outside of the provided basins. The site used during the stay must be restored to its original state. All damages caused to the vegetation, to the fences or to the campsite installations will be charged to its authors. Plants and oral arrangements must be respected. It is forbidden for the users to drive nails in the trees, to cut branches or to make plantations. It is also forbidden to delimit your campsite with personal means (wire, chains, branches, etc....), to dig or to make ditches. It is prohibited to drive stakes longer than 30 cm in the ground due to the presence of underground electrical cables. For safety reasons clotheslines are strictly prohibited between trees. You can hang your clothes up until 10 am near the trees, but it must be very discreet and do not bother people around. It's strictly forbidden to construct fence, to deprive caravans or mobil-homes of the mobilization (wheels, bar...), to store used objects. Every extension or annex in wood, metal sheet or other material (terraces over 0.60m high, rigid porch roofs, verandas, fences, plantations, etc...) is strictly forbidden. Only flexible porch roofs in extension of caravans are allowed (canvas porch roofs with a light pipe frame that is easily removable) and should be dismantled at every season's end. The surface maximum occupied by these installations doesn't exceed 30% of the place. However special dispensation authorizes awning from April until September, but they must be taken down at least on the 30/09, before annual closure. Moreover any electric installation under these awnings is strictly forbidden.

5- TRAFFIC REGULATION : On the campsite the speed limit is 10km/h and driving around the camp is strictly prohibited between 12 pm and 6 am. Only emergency services cars can drive into the camp. Parking on the site must not hold up the newcomers from setting up nor the internal services of the camp.

6- PETS : Animals must be kept on a leash, wear a collar, be tattooed and vaccinated, own a vaccination book and declared at the reception. First category dogs (fight dogs) are prohibited on the campsite (by French law of the 30.06.1992, 22.01.1985, 06.01.1999). Please make sure their droppings are done outside the campsite. Vaccination is mandatory for all dogs and other pets. The owners must be able to provide the vaccination book for checking. Pets are not allowed to roam free in the campsite. They should not stay in the campsite, not even tied up, during the absence of their owners. The owners are entirely responsible for damages caused by their pets. Pets are not admitted in public places nor in rental accommodations.

7- VISITORS : Visitors are admitted to the campsite but they are the sole responsibility of their hosts. They are bound by the campsite regulations. Visitors must ask permission to enter from the reception and state who they are visiting. Under no circumstances will visitors' cars be allowed on the campsite. To insure peace and tranquillity to the users the access to the campsite is prohibited to non-campers, vendors, door-to-door salesmen, walkers, pick-nickers, etc... Visitors can not enjoy the pool area as well as entertainment.

8- SECURITY : A/ All fires (barbecue, wood, charcoal...) are strictly forbidden. Burners must be maintained in working order and must not be used under tents nor near a car. Barbecues can only be used in designated areas Alcohol and petrol stoves are strictly forbidden. In case of a fire, warn the management immediately. B/ A first-aid kit is available at the swimming pool's lifeguard station. C/ Access gate to the campsite is closed between 11 pm and 6 am. D/ The management cannot be held responsible for the loss of personal property, theft, injury or damages that might occur to the holidaymakers or their belongings during their stay ; unless adequate proof of liability can be shown towards the campsite. In particular management is not responsible for objects stolen on the sites ; the camper is entirely responsible for his own installation. The management is responsible for the properties, which are deposited at the reception : to that effect the hire of individual safes is available for the security of your valuables. E/ Management declines responsibility for accidents occurring to children. Children should be under adult surveillance at all times.

9- GAMES : Any violent game could be organized near the installations.

10- ENVIRONMENT : You are staying in a pine forest that protects you from the heat, but that has two natural inconveniences : - pine cones falling during the warm season - branches falling during heavy winds or storms. In spite of the care brought by maintenance and pruning of the forest, the management of the campsite cannot be held responsible for damages caused by these natural events. The washing of vehicles is only permitted in the area provided.

11- STORAGE : No equipment may be left unattended on the site without prior agreement from the management and then only on designated emplacements. The management cannot be held responsible for the safety of the equipment in the absence of the owner. A fee must be paid and a list of the rates may be obtained from the reception.

2- TELEPHONE : Telephone boxes are at the disposal of all campers at the entrance of the campsites.

13- MESSAGES : All telephone calls received by the reception will be transferred by written messages placed into the boxes assigned to this purpose. The paging system will only be used in case of extreme emergencies.

14- RESPECT : Alcohol consumption is strictly forbidden in all public areas (except for the bar and restaurant) under penalty of expulsion. Management is at your disposal for all suggestions, complaints and information. A specific book or box is available to the users for potential complaints. They will be taken into considerations only if they are dated, signed, as specific as possible and relating to recent events.

15- BULLETIN BOARD : The present inside rules are shown at the entrance of the campsite and also at the reception. Those are delivered on request to the client.

16 - INFRACTION OF THE INSIDE RULES : In case of a resident, disrupt the stay of the others residents, our don't respect the dispose of the rules. The manager or his representative can orally or by written ,when he estimates necessary, can call upon this, to stop the turbid. All infraction can involve expulsion of his author. In case of serious or repeating infraction of the inside rules the manager or his representative can cancel the contract. In case of a penal infraction, the manager can call the roll of the authority. We hope that in the interest of all, everybody will observe the present regulations. Enjoy your stay, Management.
